Procedure

- 1. Mix ingredients of phase A together until homogeneous.
- 2. Mix ingredients of phase B together.
- 3. Add phase A to phase B with good agitation.
- 4. As phase A is added, increase mixer speed as the emulsion thickens to maintain good turnover.
- 5. Slowly add the ethanol to the emulsion while mixing to rapidly incorporate the ethanol as it is added
